PAUL BEVENS NEW CAL SEIA PRESIDENT

At the December 18th Board of Directors meeting held in San Diego, Paul Bevens of Familian Pipe and Supply Co., was elected to serve as President of the California Solar Energy Industries Association for 1979.

Jerry Cook, immediate Past President will retain a non-voting advisory position on the Board and Executive Committee for one year.

Other members of the Board are Frank Ames, Al Boniface, Winston Boone, Mike Boylson, Howard Kraye, Brian Langston, David Laudig, Peter Sardagna and Ying-Nien Yu. Ildiko Demeter, representing SCSEA, and Alden Bryant, representing NCSEA, also retain seats on the Board.

At the same meeting, Walter Hays, Attorney with Hays, Sanford & Latta, Inc., was selected to serve as CAL SEIA's Legal Counsel.

CAL SEIA INITIATES INSTALLATION WARRANTY PROGRAM

CAL SEIA has secured Garrett G. Steinbeck & Co., as its broker to handle their Solar Contractors Bonded Installation Warranty Program.

Application and follow-up information will be sent out to all CAL SEIA members before January 31, 1979. Upon approof applications, Garrett G. Steinbeck & Co., will prepare the General Agreement of Indemnity. When this document is signed and returned to Steinbeck & Co., a Surety file will be set up and they will issue the Installation Warranty Bond to participating members.

A one-time underwriting setup fee of \$25.00 is all that is required to participate in this program. The Program is open to CAL SEIA members only. ENERGY COMMISSION ADOPTS REGULATIONS GOVERNING SWIMMING POOL HEATING SYSTEMS.

The CAL SEIA subcommittee on many months of testimony and work with the CEC, finally saw adopted on Friday, January 5th the new requirements on Swimming Pool Heating. For the benefit of all CAL SEIA members, we have printed the text on the new regulations below.

SWIMMING POOL HEATING

- (1) The requirements of this Section shall apply after July 3, 1979.
- (2) Any new or replacement fossil fueled swimming pool heater system shall be equipped with all of the following:
- (a) An ON-OFF switch mounted on the outside of the heater for easy access to allow shutting off the operation of the heater without adjusting the thermostate setting and to allow restarting hout relighting the pilot light.
- (b) A permanent weatherproof plate or card, easily readable, giving instructions for the energy efficient operation of the swimming pool and for the proper care of swimming pool water when a swimming pool cover is used.
- (c) A length of plumbing (36" minimum) between the filter and the fossil fuel heater to allow for the future addition of solar heating equipment.

- (3) Any new or replacement fossil fueled swimming pool heater installed after January 1, 1982 shall have a thermal efficiency of at least 75% when tested in accordance with ANSI Z21.56-1975.
- (4) Outdoor pools equipped with a fossil fuel heater shall also be equipped with a pool cover.
- (5) Time clocks shall be installed on any new or replacement pool circulation pump not already so equipped so that the pump can be set to run in the off-peak electric demand period (unless required to operate an active solar pool heating system) and for the minimum time necessary to maintain the water in a clear and sanitary condition in keeping with applicable

- 3. SWIMMING POOL STANDARDS (Cont.)
- public health standards. Where public health standards require twenty-four hour operation, time clocks shall not be required.
- (6) All new pools shall be equipped with directional inlets for good mixing of the pool water.
- (7) No permit to build a swimming pool equipped with a fossil fuel or electric heating system or to install a fossil fuel or electric heating system for a swimming pool shall be issued until the following requirements have been met:
- (a) A licensed contractor shall submit to the pool owner a written bid estimate for installation of at least the following types of systems: (i) an active solar system meeting the California solar energy tax credit requirements, and (ii) a fossil fuel heating system and a pool cover. The bid estimate for each system shall also include an approximation of the annual operating cost of heating for 10 years with and without a pool cover with the proposed systems designed to maintain the pool water at 780F from May 1 through October 31 under normal weather conditions. Such bid estimates shall include but need not be limited to pool cover replacement costs. The bid estimate for an active solar system shall show any tax credit which may be available for the system. The bid estimates shall not be construed to be warranties or guarantees unless they expressly so state.

- (b) Energy prices and weather conditions used in preparing the bid estimates shall be as shown in the Residential Energy Conservation Manual.
- (c) The person for whom the system is to be installed shall certify as part of the application for a pool building permit that he has read all bid estimates as provided in Subsection (a).

Pools used for teaching, healt or therapeutic purposes are no exempt from these requirements

AB 3623 changes the definition of solar systems eligible for the tax credit, adds wind systems and solar electric systems, and makes numerous small changes including computation changes for the credit when both Federal and State tax credits are available as is the case today.

LEGISLATION RE-INTRODUCED FOR A STATE ASSISTANCE FUND FOR ENERGY

Senator David Roberti (D - Hollywood) has introduced SB 16 (SB 1600, 1978 session) which provides for the creation, organization and operation of a non-profit corporation to be known as the State Assistance Fund for Energy, California Business & Industrial Development Corporation.

Senator Roberti sponsored the same legislation last session in the form of SB 1600; however, it died in the last minutes of the legislature after it had been heard by both houses of the legislature and passed by all committees.

Assemblyman Vic Calvo (D'-Mountain View) is co-author of SB 16.

The measure would appropriate \$3,000,000 from the Energy Resources Conservation & Development Special Account for the purposes of its provisions.

The CAL SEIA Governmental Affairs Committee voted to support this measure at their meeting in October in Sacramento.

Hopefully, we will have better luck during this session in seeing that this measure is passed and signed into law.


